He graduated at the top of his law school class at Washington University Law School, was an editor of the Law Review and a member of the Order of the Coif. He did securities work in New York and then joined the U. S. Attorney's Office in New Jersey, where he was Chief of the Fraud and Public Protection Division, 1979-1983. He served as the President of Rutgers University Law School's Willard Heckel Inn of Court from 1997 to 1999 and was a Master and Chairman of its Program Committee from 1991 to 1997. He was a lecturer, Civil and Criminal Trial Advocacy, U.S. Justice Department Advocacy Institute, 1978-1982. He has received the Outstanding Professional Achievement Award from the New Jersey State Bar Association, 1983 and the Department of Justice Outstanding Professional Achievement Awards in 1979 and 1982. He is a Member of the Essex County, New Jersey State, and American Bar Associations, and the Trial Attorneys of New Jersey, and is presently a Trustee of the Association of the Federal Bar of New Jersey. He has been certified by the Supreme Court of New Jersey, Board on Trial Attorney Certification for both civil and criminal trials.
